4.	Workload of special investigation like IVP is NIL on day of assessment. Deficiency remains as it is.
5.	Radiodiagnosis department : 4 Static machines are available against requirement of 5. AERB approval is not available.
6.	Other deficiencies as pointed out in the assessment report.
