Sub: De-notification of 348.12 sq.km Revenue land of Sardarpur Kharmor Sanctuary and notification of 16.82 sq.km forestland as sanctuary in Dhar, Madhya Pradesh-FP/MP/Others/5589/2021.

Sir,

Reference is invited to the subject mentioned above. The 73rd Meeting of Standing Committee of National Board for Wild Life was held on 17th July, 2023 under the Chairmanship of Hon'ble Minister for Environment, Forest & Climate Change.

2. After discussions, the Standing Committee decided to recommend the revised proposal submitted by the State Government for alteration of the boundaries of the Sardarpur Kharmor sanctuary for reducing the area from existing 348.12 sq. km to revised area of 132.83 sq. km.


3. The State Government shall submit the notifications for revised boundaries of the Sardarpur Kharmor sanctuary, notifications for Sonawani sanctuary, Balaghat, Dr. Bhimrao Ambedkar sanctuary, Sagar and Mahatma Gandhi Sanctuary, Burhanpur and also notifications for addition of areas to the Kuno Sanctuary and New Karmajhiri Sanctuary to the Ministry.

4. Immediately after the notification for alteration of boundaries of Sardarpur Kharmor Sanctuary, the State Government shall submit the proposal for amendment in the notification of the ESZ around the sanctuary.




5. The minutes of the meeting have been posted online in the "PARIVESH" portal of this Ministry.
