Therefore, all OEMs shall hold valid EPR registration, and the registration number should be reflected in the catalogue parameter. OEMs shall ensure compliance with all responsibilities as per EPR registration applicable from time to time.

### 1. Generic

**OPTION CLAUSE:** The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 6. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 7. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. As per GFR 2017 Rule No.170 (iii), Bid securing declaration (Bid Specific) in lieu of EMD shall be submitted by the participant bidders on their organization letter head.
2. PAC for Tablet Computers is enclosed at Buyer Uploaded ATC document.
3. All Forms mentioned in the RFP shall be filled and signed by the authorized signatory of the firm.
4. In case, Bid related financial documents are submitted alongside technical documents then bidder submission will be rejected.
- 5: Manufacturer Authorization (MAF) is Mandatory for All Network Items.
- 6: In case of any Discrepancies found in details provided in GEM Bid particulars, the details given in specification document will be considered as final.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
